***In the 55 Meter Dash and 55 Meter Hurdles we will take the top eight (8) fastest times to the finals. All other races will be timed finals.

Field Events offered will be:

- ***Shot Put, Triple Jump, High Jump and Pole Vault
- ***Triple Jump **WILL NOT** be offered this year!!

Each athlete in all field events except for High Jump and Pole Vault will receive four (4) tries each with no finals. The Pole Vault and High Jump will be run to completion. Starting heights for the High Jump and Pole Vault with be decided at coaches meeting.

REMINDERS:

- 1. All teams will enter and make camp outside of the track area. No exceptions! This will allow us to keep the running area clear for just that---running!!
- 2. Check in for ALL running events will take place at the northwest corner of the track by the start of the 55m dash.
- 3. The west side of the track will be kept completely clear except for racing (dashes and hurdles).
- 4. There will be NO warm ups in the infield area!!
- 5. All equipment changes should be done in the bathrooms. The WIAA uniform rules will be enforced at all times.
- 6. Only 1/4 pyramid spikes will be allowed!!
- 7. All shots will be weighed starting one hour prior to competition behind shot ring. All poles will be checked to make sure they meet the weight requirements of the athlete.

**There will be an entrance fee for all spectators a cost of \$4.00 per adult, \$3.00 for students and \$2.00 for senior citizens. There will also be a concession stand available for you during the meet.
