PARTICIPANTS: Baraboo (boys), Berlin, DeForest, Lake Mills, McFarland, Monona Grove, Portage, Reedsburg, River Valley, Sauk Prairie, and Waunakee

LOCATION: DeForest Area High School – located off US Highway 51 North of Madison. Course maps will be sent to you before the meet.

RACE SCHEDULE: ONE RACE FOR GIRLS, ONE FOR BOYS.

4:15 - 5:30Course Open for touring and warm up4:15Coaches pick up numbers, packet, etc.5:30Boys 5000 meter race6:15Girls 5000 meter race

Awards Presented as soon as results are available.

Please bring your \$120.00 entry fee (\$60.00 per team) to the meet if not already sent.

Courses will be flagged and lined by 4:15 PM.

Courses are run on grass. The majority of the course is flat. Courses cross asphalt a number of times during the race. 1600 and 3200 meters will be marked and splits called. Coaches and spectators are not allowed on the running course while there are runners present.

Entries: <u>We will be using Accurace timing this year.</u> Make your entries through DirectAthletics at <u>www.directathletics.com</u>, with a deadline set for 8pm on Tuesday, September 2<sup>nd</sup>. <u>NO ENTRY ADDITIONS ALLOWED ON MEET DAY</u>

Check In: All head coaches must pick up packets by 4:30.

Parking: Please use the west student lot for bus and spectator parking.

Restrooms: Available in the Athletic Stadium Building. No locker rooms will be available.

- b. This committee has no authority to set aside, modify, or change defined WIAA tournament gualifying procedures or National Federation Track and Field and Cross Country rules.

Scoring: Score your first five runners with two pushers. No need to designate your top runners. All of your team is eligible to score.
